Charter Update

- LL met with HUD to review the Charter.
- Finalization is in progress; LL will send the document to HUD next week for review.
- A second round of revisions may be needed before voting at the September meeting.

Memorandum of Understanding (MOU)

- The April 2024 MOU has expired.
- LL reviewed and edited the MOU:
 - Clarified SW CoC's responsibility to establish a board.
 - o Need to define or identify the "Directors Council."
 - Requested budget vs. year-to-date comparison and grant expenditure details.
 - Added "or as required by the funder" to Section VII.B.
 - Michelle Jensen and Tanya Ostenson added as Governing Board Co-Chairs.

Attachment A: CoC Coordinator Roles & Responsibilities

- Replace all references to SMAC with SW CoC.
- Clarify the term "local service agency" in relation to HMIS LSA.

Attachment B: CE Planners Roles & Responsibilities

- Replace SMAC references with SW CoC.
- Replace "Directors Council" with "SW CoC Executive Committee."
- Replace "Coordinated Entry Planner" with "Priority List Manager."
- Request to clearly define the Priority List Manager's roles, similar to the CoC Coordinator list.

Action Items:

- Send requested changes to LL.
- LL proposed an email vote on the MOU by September 5, 2025.
- Charter review scheduled for the September meeting.

Committee Updates

- Executive Committee: Continues to meet the Thursday before each CoC meeting to set the agenda and explore new topics.
- Project Ranking & Review Committee: Plans to meet quarterly; no current updates.
- Onboarding/Welcoming Committee: No updates.
- Coordinated Entry Committee: No updates; may revise recurring meeting schedule.

Federal Funding

- The 2024 NOFO application was fully funded and expected to renew in 2025.
- Rumors suggest a new NOFO may be released this year, complicating planning.
- CoC Coordinators will meet next Friday to prepare.

Funding Notes:

- All federally funded agencies have signed onto the current NOFO.
- Sustained funding may be reduced, as seen in previous years.
- Starting October 1, 2025, CoCs will face major reductions in Family Homeless Assistance Grant funding—from \$5 million to \$1 million over two years.

Grants in Process / Upcoming

- State funding renewed for a third year: \$50,000.
- Need to spend down stipends for persons with lived experience.
- Training budget for persons with lived experience has been increased.
